

MEMBERSHIP REQUIREMENTS

All members of Asbury Park Food Collective (APFC) are required to provide the following items before commencing business at the APFC:

1. Business Licenses and Permits

- 1. Department of the Treasury IRS
 - a. Form SS-4 EIN (Apply for an EIN Online)
- 2. State of New Jersey (Starting A Business in New Jersey)
 - a. Certificate of Formation (Register your business online)
 - b. Business Registration Certificate (Mailed to you after registering a business)
 - c. Certificate of Authority (<u>Getting Registered</u>) (<u>NJ Sales & Use Tax Guide</u>)
 - d. Life Hazard Use Certificate (Bureau of Fire Code Enforcement if applicable)
- 3. County of Monmouth
 - a. Monmouth County Health Department Retail Food Vendor Application (Retail Food Vendor Application)
 - b. Board of Health Certificate (If approved, BOH Certificate is provided at pick up of Mercantile License)
- 4. City of Asbury Park
 - a. Mercantile License (Starting A New Business in Asbury Park)
 - b. Fire Suppression System Compliance Certificate (if applicable)

2. Food Handlers Certification

- A valid Food Handlers Certification is required by all APFC members.
- ServSafe trains individuals in food protection practices to ensure the safety of the food served in food
 establishments. The County of Monmouth Health code requires that supervisors of food service establishments
 and non-retail food service establishments be certified in food protection. Completion of this course and passing
 of the final exam satisfies that requirement.
- The recommended ServSafe course is a 4-hour class including exam, costs approx. ~\$180/pp, and valid for 5 years.

3. Certificates of Insurance (General Liability + Product Liability)

All members must provide a certificate of insurance covering themselves and their business for 1 million per occurrence and 2 million in aggregate for both general and product. The following entities must be listed as additional insureds:

4. Proof of Auto Insurance

• Any member that intends to park or operate a vehicle, trailer or cart on premises must provide proof of auto insurance showing coverage for the same.

5. Proof of Workers Compensation Insurance (only in the event that a business has employees)

• Any individual that is *not an owner* of the business and that *is participating in production* is viewed as an employee of the business.
